ENTRY FEES

The entry fees (\$8.00 per participating athlete) and **green fees** will be forwarded to the North Coast Section Office by the League Commissioners.

SUBMISSION OF THE CERTIFICATION OF AUTHORIZED PERSONNEL FORM

Coaches are reminded that they must submit at the NCS/Les Schwab Tires Golf Championships registration the "Certification of Authorized Personnel" form signed by the principal. Failure to submit this form may result in your school's students not being allowed to participate in the NCS/Les Schwab Tires Golf Championships. This form should be hand carried to the event, not faxed or mailed to the NCS office. If you have an assistant coach who will be attending the event it is suggested that he/she have the same form available at the tournament. Your cooperation and attention to completion of this requirement is very much appreciated.

QUALIFICATION TO THE EVENT DIVISION 2 CHAMPIONSHIP

League Champions automatically qualify plus 3 individuals not on qualifying teams.

The remainder of the field will be selected from the At-large selection committee.

The top four scoring individuals will advance to play in the Division I Tournament of Champions.

Rotation by league: **2011-12 BAC**, 2012-13 MCAL, 2013-14 HDNL, 2014-15 BSAL, 2015-16 SCL, 2016-17-CMC
Entry Fees: \$48.00 per team/\$8.00 per individual plus green fees.

The top four (4) individuals will advance to the Division I Championship.

PETITIONING UP TO DIVISION 1:

Petition applications for placement into a division of greater enrollment for the 2012 NCS/Les Schwab Tires Boys' Golf Championships were sent to school principals January 3, 2012. Petitions must be received by the NCS Office no later than February 3, 2012. Division II teams cannot qualify to the CIF Nor-Cal or State CIF Golf Championships.

DIVISION 1 QUALIFING TOURNAMENT

Second place finishers in each league that are Division I schools will automatically qualify plus 3 individuals not on qualifying teams from Division I teams.

Total Golfers 144

After the automatic entries for the Division I Qualifier are submitted by each league the NCS will determine the number of team at-large entries will be selected by the Golf Selection Committee. The top twelve (12) individuals will advance from the qualifier to the Division I Championship. The number of teams to advance to the DIV I championship will depend on the number of automatic qualifiers as league champions.

Entry Fees: \$48.00 per team/\$8.00 per individual plus green fees.

2012 DIVISION I CHAMPIONSHIP

League Champions automatically qualify plus 12 individuals not on qualifying teams from the Division 1 Qualifying Tournament and the top 4 individuals from the Division 2 Tournament. (*The Division I Championship will be played on May 14, 2012.*)

Total Golfers up to 144

1. Entry Fees: \$48.00 per team member/\$8.00 per individual **plus green fees.**
2. Game Admin.: Each team or contestant must be accompanied by the certified coach or representative of his/her school. The coach or school certificated representative must have the school principal's signature on the Certification of Authorized Personnel form.

AUTOMATIC QUALIFIERS (TEAM AND INDIVIDUAL)

18.502H Teams

Boys' Team - A qualified team in Division I may play a maximum of six players, the **five** players with the lowest scores will be used to complete the team score. A qualified team in Division II may play a maximum of six players, the **four** players with the lowest scores will be used to complete the team score.

18.503H Entries

The total number of participants, individuals, automatic qualifying teams shall not exceed 144 golfers in Division I. The total number of participants, individuals, automatic qualifying teams shall not exceed 72 golfers in Division II.

CRITERIA FOR AT-LARGE SELECTION

The criteria for selection of at-large teams for NCS Championship Series in all appropriate sports shall be a balance between:

- 1) Record over-all
 - a. League/Place co-champion
 - b. League Playoff
 - c. Non-league (pre-season/tournament/other)
- 2) Strength of Schedule
 - a. Record against top 6 opponents.
 - b. Head-to-head against teams which have qualified or are being considered.
 - c. Record against common opponents

TOURNAMENT GUIDELINES

1. The competition shall be an 18-hole tournament in which teams and individuals compete for the respective NCS Golf Championship.
2. Each team or contestant must be accompanied by the coach or his/her certificated school representative. The coach or school certificated representative must have the school principal's signature on the Certification of Authorized Personnel form. Any individual players or team that is not accompanied by his/her coach or certificated school representative who is in possession of a properly completed Certification of Authorized Personnel form will be prohibited from participating in the tournament.
3. In the past, schools have sent individual or team entries without paying the NCS participating sport fee for the NCS/ Les Schwab Tires Golf Championships. Schools that are represented by teams or individual players must have paid the respective sport fees.
4. All players, including girls competing on student teams, must play from the same tees.
5. Coaches are not allowed to coach during competition. U.S.G.A. rules will be strictly enforced along with courses local rules.
6. Coaches must marshal the course. Coaches will be assigned marshal duties at registration. Coaches are not to give advise please refer all questions to rules committee.

NO GIRLS' TEAM Fall 2011 BOYS' TEAM Spring 2012	Individual girls whose school does not have a girls' golf team may participate in the NCS/Les Schwab Tires Boys' Golf Championships if she qualifies through the league's qualifying process as a member of a boys' team. Boys' must play on BOYS' TEAM . If a school did not field a Girls' team in the fall a girl may participate on the BOYS' TEAM during the season and throughout the NCS/Les Schwab Tires Boys' Golf Championships as a team member. However, girls are not eligible for individual competition and may not compete as individuals. Girls' may only compete as individuals in the NCS Fall Girls' championship (Fall 2011) if she qualified through the league's qualifying process.

ORDER OF PLAY

Schedules will be given out at the site. Entries to Division I Qualifier and the Division II Championship Tournaments will be posted on the North Coast Section website: www.cifnco.org/golf May 2, 2012.

NCS/Les Schwab Tires Division I Championship: All team and individuals entries will be listed on the NCS Web Site - www.cifnco.org On Tuesday, May 1, 2012 entries will be listed by their group, the hole each group will start. Marshaling duties will also be listed by school or league. Each coach will be assigned a group to walk with throughout the tournament.

DRIVING RANGE

See website for more information for each tournament.

DRESS FOR PLAYERS AND COACHES (No Exceptions)

MEN: Collared golf shirts are required. Shorts may be worn and must be no more than 3" above the knee. No blue jeans (including any color designer jeans), T-shirts and tank tops are prohibited.

WOMEN: Golf shirts, slacks, skirts or shorts with no more than 3" above the knee are permitted. **No** blue jeans (including any color designer jeans), T-shirts and tank tops are prohibited.

IMPORTANT!! Shirts must be tucked in and hat bills are to be worn forward. Spectators are expected to adhere to the dress code.

PRACTICE ROUNDS

Practice rounds will be available at the normal junior rate prior to the tournament. Players from distant schools desiring tee times on Sunday before will be subject to availability at the courses normal junior rate. Reminder there is no practice/coaching on Sunday.

ELECTRONIC GOLF CARTS AND CADDIES

18.604H: Players must carry their own clubs or transport them on a pull cart (caddies and golf carts are not permitted)

ELECTRONIC DEVICES

Electronic devices, (i.e. range finders, ipods, etc.) are not allowed during North Coast Section Championship play.

GALLERY

18.605H: A gallery is permitted, however all gallery members must remain at a distance of 30 yards from the players at all times and are not to walk on the fairways. Participants are reminded of Rule 8 (Advice and Assistance) of "The Rules of Golf" which specifically prohibits players from receiving any counsel or suggestions from anyone (including their coach, other players, gallery, etc.) that could influence them in determining their play, the choice of club, or the method of making a stroke. *Note: Course rules may prohibit gallery.*

SUPERVISION

Since coaches will be given the supervision duties of their athletes while traveling to and from the qualifier site golf course and during the time they are present in the area of the qualifier site, it will be necessary for coaches to supervise their athletes if they golf on Sunday, May 6th. As long as the coach does not do anything, which would fall into the category of the coaching definition as outlined below, they may, and would be expected to, supervise the student-athletes under their charge.

Coaching and Practice

Many teams will travel to the NCS/Les Schwab Tires Golf Championships. Since the championships will take place early Monday morning, May 7th, most coaches and their teams will arrive Sunday, May 6th. The question comes up yearly about teams or individuals golfing on Sunday and whether this is a violation of CIF rules. Hopefully, this information will clarify the position of NCS.

North Coast Section schools are obligated to follow all CIF, NCS, league and school/district rules regarding educational athletics and supervision of students. CIF and NCS have rules against Sunday games or practices.

CIF Bylaw 308 states that, **no** interscholastic games or practice of any kind are to be held on Sunday. Therefore, it is clear that no coach may do anything on Sunday that would be considered coaching. Coaching is defined by the NCS Sport & General Rulings Handbook Bylaw 200H as the association of a coach or coaches with a potential team member or members for the purpose of teaching the mental or physical skills of a CIF approved sport. Clearly, any coaching, as defined above, on Sunday, May 6th, would be a violation of CIF rules.

COACHING

Coaching of athletes during competition is not permitted. Coaches should review Rule 8 of the USGA Rules of Golf - Advice, specifically Decisions 8-1/22 and 8-1/24. Coaches must Marshall the course. Coaches will be assigned Marshal duties at registration.

RULES

U.S.G.A. rules will apply. Exceptions based on local club rules may be noted on the scorecard.

COURSE RULES

A detailed list of course rules will be handed out at registration.

LUNCH

Box lunches will be given to each participating player only.

SOUVENIRS

Schools may purchase or order NCS championship T-Shirts (\$17.00, XX Lg. shirts are \$19.), Long sleeve T-shirts(\$20.00, XXL \$22.00) Sweatshirts (\$33.00, XXL Sweatshirts are \$35.00), Visors (\$13.00), Hats (\$17.00), Patches (\$17.00) Polar Tec Vests (\$48.00), Wind Shirts (\$48.00, XXL \$50.00), and Polo shirts (\$28.00, XXL \$30.00) at the NCS/Les Schwab Tires Golf Championships. Coaches, participants and spectators may use check, cash, MasterCard, Visa, Discover, school purchase order, requisition form and school billing to purchase souvenirs.
