NCS/LES SCHWAB TIRES DUAL TEAM CHAMPIONSHIPS

- The NCS/Les Schwab Tires Dual Team Championships will take place Saturday, February 11, 2012 at Foothill HS (Div II EB/Div I EB) and Lower Lake HS (Div III and Div II RE). Teams who qualify are **required** to participate with their regular varsity team members. The dual team rotation is:

- Automatic entries will be posted on the NCS website on the evening of Thursday, February 9, 2012. Additionally, up to two teams may be selected for entry as an at-large team in any division if a school does not automatically qualify for the dual team championship. If you would like to apply as an at-large team, complete the at-large application form (in the championship bulletin) and submit prior to Thursday, February 9, 2012, 10:00 pm.
- Bracket sizes will be no less than eight teams and no more than 10 teams. Team finishes will be determined out to at least fourth place and awards will be given for places one through four.
- Any matches wrestled in the NCS/Les Schwab Tires Dual Team Wrestling Championships do not count towards the CIF 40-match limit, however, the results must be listed in the record of each athlete who qualifies to the NCS/Les Schwab Tires Boys' and Girls' Wrestling Championships. Girls are eligible for the Dual Team tournament as part of a student team, but must wrestle according to boys' wrestling weights.
- Each school must submit their school's NWCA Pre-Match Weigh-in Form to the Tournament Director. Wrestlers are not eligible for competition if this form is not submitted or if a wrestler is not present on the form.

NCS/OS/LES SCHWAB TIRES GIRLS' WRESTLING CHAMPIONSHIPS

- The NCS/OS/Les Schwab Tires Girls' Wrestling Championships will take place Friday-Saturday, February 10-11 at Pittsburg HS.
- The seeding meeting will take place Sunday, February 5 at the North Coast Section office (12925 Alcosta Blvd., Suite 8, San Ramon) according to the following schedule: 8:30 – 9:45 a.m. – A representative from each league or individual coach will submit entries from their league/school. 10:00 a.m. – Coaches present will seed each bracket (max of 8 seeds). Brackets will be available Monday, February 6, 2012.
- The Headquarters Hotel is the Hampton Inn & Suites, located just minutes from Pittsburg HS (<http://hamptoninn.hilton.com/en/hp/hotels/index.jhtml;jsessionid=QLBEFRTYLXXRGCSGBJC222Q?ctyhocn=SANPBHX>). Schools are encouraged to contact the hotel as soon as possible to reserve room(s).
- Bring the "Certification of Authorized Personnel" form, completely filled out and signed by your principal, to registration. This form will be used to determine who and how many coaches receive wristbands. Without the completed form, students from your school will not be allowed to compete. DO NOT fax the form to the NCS office prior to the championships.
- Bring the NWCA Pre-Match Weigh-in Form to registration.
